## **ABOUT THE COMPANY:**

The Utilities Regulation and Competition Authority ("URCA") of The Bahamas came into effect on 1 August 2009 as the converged regulator for the Electronic Communications Sector (ECS) – covering broadcasting, radio spectrum and electronic communications. On January 28, 2016 URCA became the regulator of the Electricity Sector (ES) in The Bahamas. The new sector was added to URCA's responsibilities with the passing of the Electricity Act 2015 (EA) and the URCA (Amendment) Act 2015 on December 30, 2015.

URCA is further strengthening its capacity in policy and regulation of the Electronic Communications Sector and is seeking to employ a suitable qualified individual to fill the post of Regulatory Officer, Technical in the Electronic Communications Department. The position will be based in The Bahamas and will report to the Director Electronic Communications at URCA or designate.

## A. CORE DUTIES – Regulatory Officer, Technical:

The successful candidate will be required to:

- Assist policy and regulatory teams in technical cases and projects within URCA, in accordance with URCA's strategy and sector policy.
- Assist with formulating policy positions for URCA supported primarily by technical input, industry
  experience and international regulatory practices with additional support by legal opinion
  and economic analysis
- Support project lead and cases with emphasis on technical regulatory matters
- Assist technical team in cases and projects, including publication of guidelines, consultation, and determinations
- Assist with technical implementation of regulatory decisions
- Support other technical staff members in developing scenarios for the electronic communications market.
- Carrying out assignments to agreed quality standards and timescales to achieve high levels of customer satisfaction.

- Bachelors Degree from an accredited University/College in Telecommunications or Electrical Engineering
