"hell to the NO." But, things are changing, and according to this press release by The Utilities Regulation & Competitions Authority (URCA) it appears that you may be paying something in the future to access 916 whether you like it or not. URCA is requesting public consultation on the matter.

916 is the nationwide number in the Bahamas for Directory Assistance...our very own 4-1-1 if you will.

According to Wikipedia "in the US, you can pay anywhere from \$1.25 up to \$3.49 for a 4-1-1 call, depending on if the call is local, national or within a particular state, plus taxes"

The Press Release simply states that URCA requires BTC to propose a fee for directory services (916) and

informational services (915). The Bahamas Telecommunications Company (BTC) has responded back stating that they would like to charge each customer a .35 cents fee for using 916 Directory Assistance from a landline or cellphone. The charge would appear in your regular monthly billing, or deducted from your prepaid minutes.

According to URCA, paying for directory assistance calls is a common practice in the region, it helps to produce fairness and competition. The directory service is viewed as an added service or convenience feature. This is because customers can use either the free yellow pages book, or the multiple online yellow page 'e-directories' such as my favorite www.bahamasypmobile.com to obtain directory assistance by themselves.

URCA's response to BTC's .35¢ per call are:

-BTC should allow the public to have three free 916 calls per month on their landlines – charging for
the fourth call.
-BTC can charge their suggested .35 cents if the customer calls from a mobile phone
-Calls from Pay Phones should be free because yellow pages are often unavailable at those locations.
-Customers at times require more up-to-date contact information that may have missed yellow page
publication (or might not have been updated online yet).

BTC would rather charge .35¢ across the board.

I like URCA's suggestions, but I also do not take issue with BTC's proposal to charge across the board for the service. In my mind, this will foster the creation of new ways to access yellow page information across the nation, as intended by URCA. In other words, competition...new tech startups...more jobs, three possibilities I enjoy thinking about!

The biggest losers here will be businesses whose employees will continue to use the service willy-nilly. It may seem insignificant for residential landlines, but the cost of owning a business landline will more than likely increase significantly. This makes business customers the perfect target for tech startups that can deliver a similar 9-1-6 directory service for a fraction of the cost...A fraction of .35 cents however, doesn't seem very attractive. Innovation will be key.
