### ABOUT URCA

URCA is seeking to employ a recent university graduate to fill the Assistant Regulatory Officer (Technical) post in the Electronic Communications Department. The successful candidate will provide expertise and competency in engineering and technical regulations and perform tasks as assigned by the Director of Electronic Communications and Regulatory Managers including:

- Assisting URCA's Electronic Communications Team in resolving technical cases and projects in accordance with URCA's strategy and sector policy.
- Assisting with formulating policy positions and regulatory interventions for the electronic communication sector that conform to industry best practices and international regulatory standards.
- Collaborating with URCA's Engineering, Legal and Economic Teams to advance URCA's mandate.
- Assisting project leads in completing departmental projects.
- Assisting the Technical Team in resolving cases and projects, such as publishing guidelines, consultation, and determinations.
- Assisting with the implementation of licensing guidelines and the monitoring and enforcement of the sector laws and regulations
- Assisting with the implementation of regulatory decisions.
- Assisting the Technical Team in developing scenarios for the electronic communications market.
- Executing assignments to agreed quality standards and timelines to achieve high levels of stakeholder satisfaction.
