PUBLIC REGISTER

(Pursuant to Section 14 of the Natural Gas Act, 2024)

The Utilities Regulation and Competition Authority (URCA) will keep a register of all licensees under this Act.

The Public Register is in electronic form however, URCA will maintain hard copies of its Public Register at its principal office for inspection by the public on request during normal business hours without charge.

URCA will also maintain hard copies of Licences at its principal office for inspection by the public on request during normal business hours without charge.

Where any member of the public requires or requests a hard copy of the Public Register or a licence document, URCA will make the same available at a fee as contained in the Fee Schedule published by URCA. The Fee Schedule may be revised from time to time.

URCA will regularly update the Public Register.
